Motion made by Robert Johnson seconded by Judy Baker to purchase a sewer sampler pump at a cost of \$261.11. Motion carried with all ayes.


A rubber snake was found in a fire truck. Bryan Cathey carried the snake to Robert Johnson's house to show him.
